1 Thomas A. Seaman ("Receiver"), the court-appointed permanent receiver for
2 Small Business Capital Corp. ("SB Capital"), Investors Prime Fund, LLC ("IPF"),
3 SBC Portfolio Fund, LLC ("SPF") and their subsidiaries and affiliates (collectively,
4 "Receivership Entities"), submits this twelfth interim application for approval and
5 payment of fees. This application covers the three-month period August 1, 2015,
6 through October 31, 2015 ("Twelfth Application Period").

7 During the Twelfth Application Period, the Receiver and his staff spent
8 654.1 hours at a weighted average hourly rate of \$180 per hour for a total cost of
9 \$117,769.00, an 18% decline from the Eleventh Application Period. Effective
10 August 1, 2014, the Court began reviewing the Receiver's invoices for loan
11 servicing. The amount for loan servicing during the Twelfth Application Period was
12 \$24,849.50. The total fees of \$117,769.00, less these loan servicing fees of
13 \$24,849.50, is \$92,919.50. The Receiver now seeks approval of his fees in full and
14 authority to pay 90% of the remaining \$92,919.50 on an interim basis, or
15 \$83,627.55.

16 Significant progress in all aspects of the case was made during the Twelfth
17 Application Period. The Receiver continued to efficiently service the loan
18 portfolios, which generated a profit of \$100,811 for the quarter. The Receiver also
19 concluded marketing efforts and conducted a bidding process resulting in final
20 submission of the highest approved bidder for the remaining 7-A loan portfolio and
21 SBA license, and worked to obtain final SBA approval. On December 24, 2015 the
22 Receiver was informed the SBA will approve the sale and the Receiver will file a
23 motion to approve the sale, which will generate approximately \$4.9 million in cash
24 and lead to a final distribution and conclusion of the receivership.

25 The Receiver also administered investor inquiries and filed reports with the
26 Court and otherwise executed the duties set forth in the Temporary Restraining
27 Order and Order Appointing Receiver entered on June 26, 2012 ("TRO"), the

1 Preliminary Injunction Order entered on July 10, 2012 (“PI”), and subsequent orders
2 of the Court.

3 Marketing the loan portfolios and SBLC license for disposition and
4 administering the sale process composed over 55% of the fees during the Twelfth
5 Application Period. Loan servicing work represents 21% of the amount requested in
6 the Twelfth Application.

7 During the Twelfth Application Period, the gross receipts from all sources
8 were \$4,578,984.76. The cash balance as of October 31, 2015 was \$7,115,550.71.
9 The Receiver’s fees as a percentage of the gross receipts during the Twelfth
10 Application Period were 2.6%. Inception-to-date, the Receiver’s fees are
11 \$2,633,338.50 which is 3.8% of gross receipts. Interim distributions to investors
12 and claimants to date are \$24,500,000. The Receiver’s fees as a percent of total of
13 the amount distributed to date and the current cash balance to date are 8.3%, which
14 percentage should decline to less than 8% at the conclusion of the receivership. The
15 foregoing metrics indicate that the amount of the Receiver’s fees is reasonable based
16 on the size of the cash flow and receivership assets. In addition, the total includes
17 fees related to the Receiver’s activities which are necessary and properly incurred
18 but do not generate revenue to the estate, including supporting discovery requests of
19 interested parties, quarterly reporting to the Court and interested parties,
20 administration of claims, making distributions, and investor communications.
21 During the Twelfth Application Period, the Receiver and his agents responded to
22 numerous investor inquiries about distribution checks and related matters.

23 **I.**

24 **WORK PERFORMED BY THE RECEIVER**

25 During the Twelfth Application Period, the Receiver and his agents and
26 counsel worked diligently to operate the Receivership Entities and administer the
27 receivership estate. Significant progress toward completion of the case has been
28 achieved. The Court may recall that it approved sale of the 7-A loan portfolio and

1 SBA license in May 2015 which had been expected to close in June 2015. The
2 buyer in the sale was not able to perform and the Receiver reopened the marketing
3 and bidding process. As set forth in the Receiver's Fifteenth quarterly report, the
4 only remaining tasks will be prosecuting the litigation against CBB, final disposition
5 of the SBA's claim, providing information in support of Feathers' appeals, filing
6 final tax returns, distributing the cash in the receivership estate to investors, and
7 concluding the case, if approved and authorized by the Court.

8 The Receiver's work during the Twelfth Application Period is more
9 specifically discussed below.

10 **A. Manage Loan Portfolios and Loan Servicing**

11 The Receiver and his staff managed the loan servicing operations of the
12 Receivership Entities. The Receiver fulfills the servicing obligations imposed by
13 the SBA on its lenders with the assistance of his staff, which includes a CPA and
14 SBA loan specialist with 31 years' experience servicing SBA loans. The Receiver's
15 staff collects loan payments and monitors payment status. The Receiver also
16 properly accounts for loan payments and makes the corresponding payments to
17 participating lenders. Management of the loan servicing operations also entails
18 continuously monitoring the credit status of borrowers and compliance with non-
19 monetary covenants of the loans, including monitoring insurance coverage, status of
20 property tax payments, many of which had been found to be delinquent, and
21 obtaining and reviewing borrower financial statements.

22 Management of the loan portfolios also requires resolving problem loans and
23 enforcing the lender's rights. As set forth in the Receiver's Fifteenth Interim
24 Report, the Receiver has maintained a watch-list of potentially problem loans, either
25 because of slow payments, payment defaults, failure to pay property taxes, or other
26 *indicia* of credit issues. During the Twelfth Application Period, the Receiver made
27 significant positive progress with regard to several slow paying or otherwise
28 impaired loans. No borrowers are in monetary default, however completion of the

1 3 AM, LLC loan foreclosure action consumed resources in the Twelfth Application
2 Period when all appeals had been exhausted and the sales proceeds were received.

3 Numerous borrowers have been in default on loan covenants, in particular
4 with regard to keeping property taxes current, submitting financial statements,
5 maintaining adequate insurance, and other non-monetary defaults. As set forth in
6 the Receiver's Fifteenth Interim Report, significant progress in curing these non-
7 monetary defaults, which if not addressed in accordance with the SBA's Standard
8 Operating Procedures ("SOP") put the SBA guarantee at risk, has been made during
9 the Twelfth Application Period and the loan portfolio is stable. There are only two
10 of 30 loans on the Receiver's watch list. The Receiver ensured timely payment of
11 loans and resolved servicing issues, including resolution of unpaid property taxes.
12 The Receiver believes this work has enhanced the value of the loan portfolios and
13 lead to obtaining fair value for the loans.

14 In addition to collecting servicing income, the Receiver has aggressively
15 pursued collection of late fees and has collected an additional \$39,361.09 in late fees
16 since being appointed. No late fees were collected during the Twelfth Application
17 Period. The aggressive collection of late fees has improved loan collections, which
18 preserved and increased the quality of the loan portfolios and resulted in higher bids
19 for the loans.

20 The Receiver continues to obtain and monitor current financial statements and
21 tax returns to ensure compliance with SBA regulations. The Receiver also monitors
22 insurance on the loan collateral and ensures that all loan collateral is fully insured.

23 Finally, the SBA's SOP 5057 and 504 FMLP Guidelines require the servicer
24 to conduct site visits either annually or in the event of a default and the Receiver is
25 in compliance with this requirement.

26 Management of the loan servicing operations also requires compliance with
27 SBA and DRE regulations and oversight. The Receiver is in compliance with all
28 regulatory filing requirements.

1 During the Twelfth Application Period, the Receiver's fees attributable to loan
2 servicing were \$24,849.50, or \$8,283.17 per month. The Receivership Entities
3 collected \$60,322.10 in servicing fees during the Twelfth Application Period and the
4 estate therefore realized a net profit of \$35,472 from loan servicing operations, not
5 including the interest earned on the loans of \$65,338.88. Servicing fees and profits
6 declined when the 504/FMLP loans were sold (which have a higher servicing
7 component than 7-A loans) and continue to decline as 7-A loans are paid off.

8 **B. Sales and Liquidation of Assets**

9 During the Twelfth Application Period, the Receiver reopened marketing,
10 submitted prospective buyers' SBA lender applications to the SBA, and negotiated
11 sale of the 7-A loans and the SBLC license, which is now pending Court approval.
12 The sale process involved extensive coordination with the SBA relative to the
13 process and approval of potential buyers. The Receiver's agents and the broker
14 uploaded the loan files and due diligence materials to an electronic platform that
15 prospective purchasers are able to access. This work required extensive
16 organization and review of files comprising over 100,000 pages and took nearly two
17 months to complete. The Receiver believes that by fully disclosing the terms of the
18 loans in a well-organized manner, and providing an efficient mechanism for
19 prospective purchasers to conduct due diligence, and fully supporting bidders
20 inquiries, the full value of the loans is being realized. Completion of the sale(s) will
21 lead to a final distribution to investors and conclusion of the receivership.

22 Work on selling the 7-A loan portfolio and the SBA license was extensive
23 during the Twelfth Application Period. The Receiver supported an extensive and
24 very thorough process to obtain SBA approval which required the assistance of the
25 Receiver and his staff. The cost of selling the assets was \$65,304.50 and represents
26 approximately 55.5% of the fees incurred during the Twelfth Application Period.
27 Given the complexity of the process required to properly market the loans and
28 SBLC license and coordinate the sales with the SBA, the Receiver believes his fees

1 are fair and reasonable and will directly benefit investors when the sales are
2 concluded. More specifically, at this time the Receiver expects to be able to return
3 at least 80% of investors' losses once the sales are closed and the receivership is
4 concluded.

5 **C. Administration of the Receivership Estate**

6 The Receiver supported the discovery requests of interested parties during the
7 Twelfth Application Period. The Receiver also prepared and filed detailed quarterly
8 accounting and status reports to the Court and interested parties. To date, 15 such
9 reports have been prepared and filed, plus two additional special reports to the Court
10 concerning asset sales and distributions. The reports provide interested parties with
11 a complete assessment of the status of the receivership estate and its assets. Federal
12 and state tax returns for all Receivership Entities, both pre and post-receivership,
13 have been filed. During the Twelfth Application Period, fees for administration of
14 the receivership estate, excluding loan servicing and the loan sales, were \$9,204 per
15 month.

16 **D. Third Party Recoveries**

17 The Receiver investigated claims against California Business Bank and
18 sought and was granted approval to bring litigation seeking damages for
19 misrepresentations and omissions in connection with the Receivership Entities'
20 investment of \$990,000 in California Business Bank common stock, which promptly
21 plummeted to less than \$43,000 after the purchase. During the Twelfth Application
22 Period, the Receiver managed the ongoing litigation.

23 **E. Investor Claims and Distribution Plan**

24 The Receiver made a third distribution of \$2,500,000 to approximately
25 350 investors in July 2015. Together with the first and second distributions of
26 \$22,000,000, this brought all investors to over 64% recovery of their investment
27 (including any amounts they may have received prior to the time of the TRO in
28 accordance with the Rising Tide method approved by the Court). The Receiver also

1 maintained the www.sbcapitalreceiver.com website with reports and significant
2 developments of the case for efficient investor communications. During the Twelfth
3 Application Period, the Receiver updated the website three times. Each time an
4 email informing investors of the update was sent automatically to all subscribers of
5 the website.

6 **F. Summary of Total Fees for Receivership**

7 The total fees of \$2,633,338.50 incurred since the inception of the case
8 through October 31, 2015, can be broken down into the following categories of
9 work.

14 The total average cost to operate the Receivership Entities, administer the
15 receivership estate, and sell assets was approximately \$64,227 per month over the
16 life of the receivership and decreased to \$39,256 per month for the Twelfth
17 Application Period. The total fees for the Twelfth Application Period declined 19%
18 from the fees in the Eleventh Application Period.

19 The Receiver has previously been paid \$1,760,720.40 and therefore has an
20 unpaid balance of \$872,618.10 as of October 31, 2015.

21 Exhibit A provides a detailed listing of each and every time entry comprising
22 the Receiver's fees. In order to assist the Court, the Receiver has prepared two
23 separate analyses. The first is a breakdown by timekeeper setting forth the amount
24 of time spent by the Receiver and his agents at their respective hourly rate. The next
25

1 is a breakdown of work by functional area including accounting and reporting,
2 administration, bookkeeping, financial analysis, investor relations, litigation and
3 support, loan servicing, project management, Receiver services, receivership
4 administration and the selling and liquidation of assets.

5 **G. Charges by Timekeeper**

6 Exhibit B provides a breakdown by timekeeper setting forth the amount of
7 time spent by the Receiver and his agents at their respective hourly rates. The
8 Receiver personally expended 22.6 hours (7.5 hours per month, or approximately
9 5% of his time) for the Twelfth Application Period for a total cost of \$8,255.00. In
10 order to manage the Receivership in a cost effective manner, the Receiver delegates
11 some assignments to agents who are billed at hourly rates ranging from \$65 to \$200
12 per hour. These agents perform accounting, bookkeeping, financial analysis,
13 business management, investor relations and claims management, debt collection,
14 litigation support, loan servicing, management of asset disposition, paralegal and
15 other services required by the receivership estate. During the Twelfth Application
16 Period, the Receiver's agents expended 631.5 hours at an average hourly rate of
17 \$173 per hour. The Receiver expects the number of hours necessary to administer
18 the receivership estate to decrease now that the assets are under contract for sale, the
19 three distributions have been made, and the servicing of the loan portfolios is stable.

20 By using qualified agents at significantly lower hourly rates, the Receiver was
21 able to achieve a weighted average hourly (blended) rate of \$180 per hour for the
22 Twelfth Application Period.

23 As set forth in his proposal to the SEC filed with the Court in its motion for a
24 TRO, the Receiver discounted his normal hourly rate from \$400 to \$375, as well as
25 making an additional discount related to the Receiver's phone calls directly with
26 investors which are billed at \$100 per hour, which resulted in costs savings of \$785
27 during the Twelfth Application Period. In order to further conserve assets, the
28 Receiver agreed to not bill for travel time which normally would be billed at 50% of

1 the timekeeper's rate or for travel expenses. There was no travel to Court during the
 2 Twelfth Application Period. Finally, the Receiver did not charge for the cost to
 3 prepare fee applications which resulted in additional savings of \$2,905. The sum of
 4 the aforementioned discounts is \$3,690 for the Twelfth Application Period.
 5 Inception-to-date, the savings are \$147,035.64.

6 The Receiver believes the hourly rates charged by the Receiver are
 7 appropriate given the requirements of the receivership estate and the total fees for
 8 which the Receiver seeks approval are fair and reasonable.

9 **H. Charges by Task**

10 Exhibit C provides a monthly breakdown by tasks performed by the Receiver
 11 and his agents, including total costs for each task by month, and a pie chart of all
 12 tasks for the entire Twelfth Application Period. The total hours and cost by task for
 13 the period are as follows:

24 **CONCLUSION**

25 The Receiver's fees are fair and reasonable in view of the experience and skill
 26 required, work performed, circumstances encountered, and results achieved. The
 27 Receiver has worked diligently to perform his duties in an efficient and cost-
 28 effective manner. Therefore, the Receiver respectfully requests an order:

1 Approving fees of \$92,919.50 for the Twelfth Application Period;
2 Authorizing the Receiver to pay 90% of such sum, or \$83,627.55, from assets of the
3 receivership estate; and for such other and further relief as the Court may deem
4 appropriate.

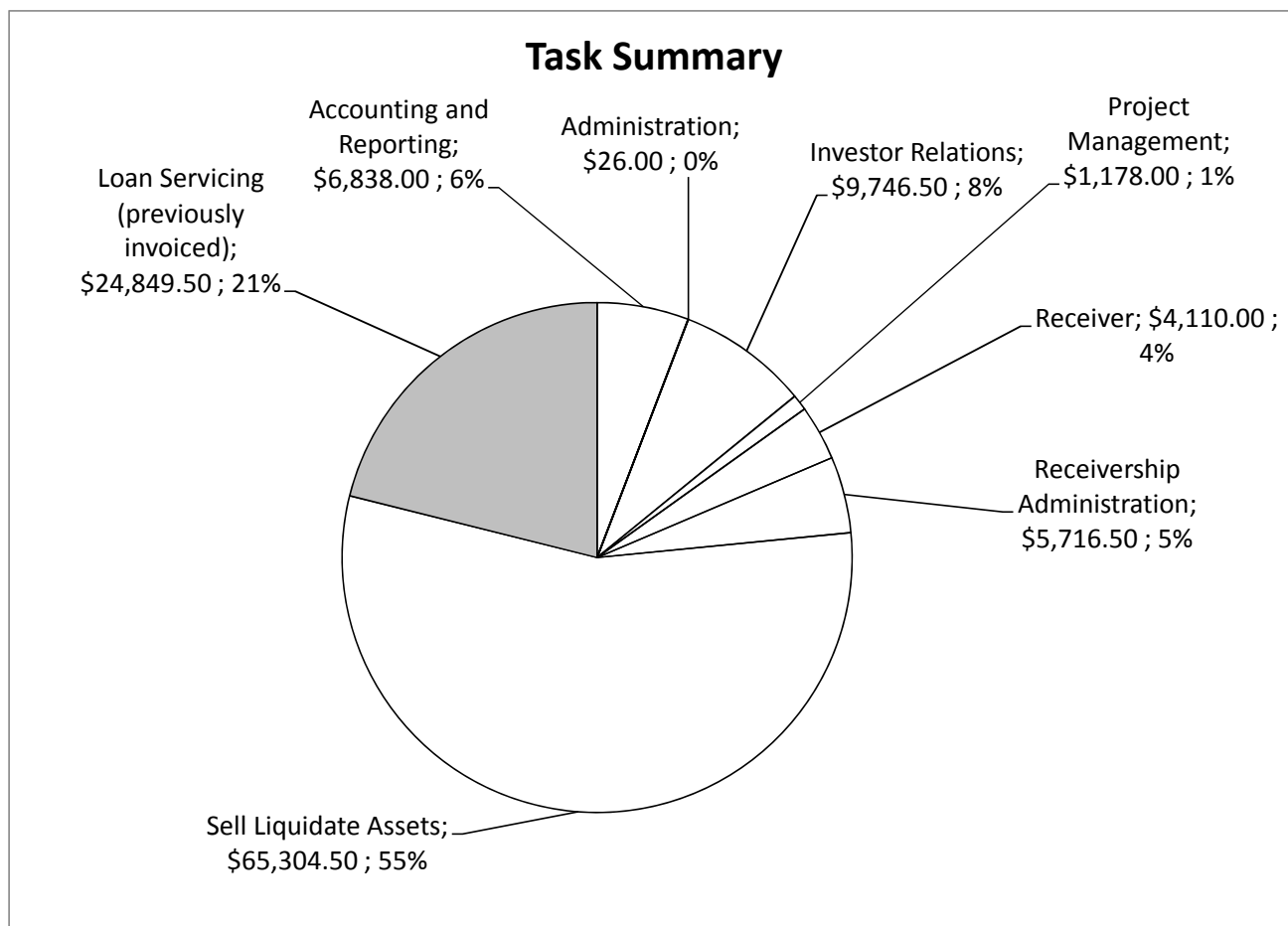
